4. In view of this, the candidates are advised to attend the Online PCP as per schedule given above. The Course Coordinator concerned Department will conduct an Online test of each subject (Theory Papers) of UG Part-I/II, III P.G. Part-I,II and the courses of One year duration to meet the requirement 20% internal assessment. This test will be held in the last two days of PCPs.
