2. Since the PCP's are conducted for the benefit of the DDE students and as mentioned in the Prospectus 50% attendance in the PCP is COMPULSORY to become eligible to appear in the University examinations, they are advised to attend the PCP classes regularly. No exemption from attending the PCP will be allowed in any case No change of PCP centre/batch will be entertained in any case.
3. The candidates are also advised to pay the balance fee/2<sup>nd</sup> Instalment of fee and submit the deficient documents, if any, immediately to confirm the eligibility for appearing in the University examination failing which they will not be allowed to appear in the University examinations.
4. The students will have to make their own arrangements for their boarding and lodging during the course of the PCP. However, at Kurukshetra there are a number of "Dharamshalas and Yatri Niwas" of Haryana Tourism with mess facilities on the main road near the University which can be contacted for the purpose.
5. The candidates are advised to attend the PCP as per schedule given above. The Course Coordinator of the concerned Department will conduct a written test of 30 minutes duration each subject (Theory Papers) of UG Part-I/II/III, P.G. Part-I/II/III and the courses of One year duration to meet the requirement of 20% Internal Assessment. This test will be held in the last two days of PCPs., 20 questions of MCQs are required to be answered by the candidate.
6. Those candidates who do not appear internal assessment test or take late admission their 20% proportionate marks of the marks obtained in final examination shall be treated as score of internal assessment. The internal assessment once awarded will not be revised afterall.
