4. Online (Objective Type) test will be held on account of 20% Internal Assessment in each theory paper during the last two days of PCP. Those candidates who do not appear in internal assessment test or take late admission their 20% proportionate marks of the marks obtained in final examination shall be treated as score of internal assessment.

In view of this, the candidates are advised to attend the PCP, though submission of written assignment is not compulsory, the students in their own interest are also advised to submit written assignments on topics concerning their courses for evaluation by the teacher.
