**Note: The Registration of the Students will be done one hour the first day of PCP.**

- Since the PCP's are conducted for the benefit of the DDE students and as mentioned in the Prospectus 50% attendance in the PCP are COMPULSORY to become eligible to appear in the University examination, they are advised to attend the PCP classes regularly. No exemption from attending the PCP will be allowed in any case. No change of PCP centre/batch will be entertained in any case.
- The candidates are also advised to pay the balance fee/2<sup>nd</sup> Instalment fee upto 31-1-2018 and submit the deficient documents, if any, immediately to confirm the eligibility for appearing in the University examination failing which they will not be allowed to appear in the University examinations.
- The students will have to make their own arrangements for their boarding and lodging during the course of PCP. However, at Kurukshetra there are a number of "Dharamshalas and Yatri Niwas" of Haryana Tourism with mess facilities on the main road near the University which can be contacted for the purpose.
- In view of this, the candidates are advised to attend the PCP as per schedule given above. The Course Coordinator concern Department will conduct a written test of 30 minutes duration each subject (Theory Papers) of UG Part-I/II, P.G. Part-I and the courses of One year duration to meet the requirement 20% internal assessment. This test will be held in the last two days of PCPs 20 question of MCQ are required to be answered by candidates.
- Those candidates who do not appear in internal assessment test or take late admission their 20% proportionate marks obtained in final examination shall be treated as score of internal assessment. The marks of internal assessment once awarded will not be revised after all.
