1. The seats will be filled up as per the reservation policy of Haryana government and first the seats will be filled up in all India category (Including Haryana) irrespective of category. Rest seats will be filled as per the respective category.
2. For this purpose, you are required to get the following Original documents checked:
 - (i) Certificate of qualifying Examination alongwith an attested copy.
(Matriculation Onward)
 - (ii) Certificate of Teacher Education Qualification through face to face Mode i.e. D.ELED/B.ELED, etc.
 - (iii) Current teaching certificate as required:
A candidate must submit proof of having IN-SERVICE WORKING TEACHING EXPERIENCE on the prescribed format given in the DDE website at Annexure-XII.
 - (iv) Category Certificate for which you have claimed RESERVATION alongwith an attested copy.
Backward class category candidates are required to submit an Affidavit (Annexure-V) in the DDE website. All the above BC students must submit an affidavit from their parents with regard to creamy layer as per (Annexure VI) in the DDE website.
 - (v) Migration certificate or Affidavit duly attested by the Magistrate Ist Class in case of students who have passed their last examination from the University other than the Kurukshetra University, as per proforma given in the Prospectus at (Annexure-XI) in the DDE website to the effect that they will not be appearing in any other examination simultaneously from any other University during the session.
 - (vi) Character Certificate from the Head of the Institution last attended OR from a Gazetted Officer/Sarpanch.

3. Fee amounting to Rs.30,000/- as prescribed in the Prospectus will have to be deposited immediately after getting the documents checked and after confirmation of your admission on the date of checking of the documents.
4. Fee can be deposited either in cash directed at the counter of the Oriental Bank of Commerce in the premises of the University or through crossed Bank Draft drawn in favour of the Registrar, Kurukshetra University, payable at Kurukshetra/Thanesar only. However, it is advisable to bring fee in the form of Bank Draft.
5. After Counseling you have to get stamped on your Identity Card at Room No. 107 and collect the study material after showing the proof of admission at Room No.114. You are advised to bring extra photograph (Passport size) with name and Reference No.
6. If any time subsequent to admission it is discovered that the information given in the application form or in the certificates attached by you is false OR any misrepresentation/error/concealment/omission has been noticed the admission will be cancelled ab-initio and all dues paid by you shall be forfeited.

Please note that no further extension in the date to deposit fee & documents, specified as above, will be allowed under any circumstances whatsoever. After depositing the requisite fee, Identity Card be obtained from the office in token of your admission.
