- (1) In case of late submission of Dissertation/ Project Report/ Mini Project Report/ Training Report/Term Paper Report/ Field Training Report/Research work etc. beyond the prescribed dates as laid down in the concerned Ordinances of all UG/PG (Vocational/ Professional) Degree/ Diploma/ Integrated Courses i.e. BA/ B.Sc. / B.Com/ BBA/ B.Voc./ MA/ M.Ed./ M.P.Ed./ MCA/ MBA/ MTM/ M.Tech./ M.Sc.Tech/ LLM/ M.Phil etc. examinations, the Dissertation/ Project Report/Mini Project Report/Training Report/ Term Paper/ Field Training Report/Research work etc. may be accepted on payment of the following Penalty by the concerned student:-

01	Within Normal Period of course	Nil
02	Within one year after expiry of the normal period	1000
03	Within next one year (2 <sup>nd</sup> year) of normal period	3000
04	Within next one year (3 <sup>rd</sup> year) of normal period	6000
05	Within next one year (4 <sup>th</sup> year) of normal period	10000
06	Within next one year (5 <sup>th</sup> year) of normal period	15000
07	Within next one year (6 <sup>th</sup> year) of normal period	21000
08	Within next one year (7 <sup>th</sup> year) of normal period	28000
09	Within next one year (8 <sup>th</sup> year) of normal period	36000
10	Within next one year (9 <sup>th</sup> year) of normal period	45000
11	Within next one year (10 <sup>th</sup> year) of normal period	55000
