Note:- 1. The Registration of students will be held from 10.00 a.m. to onwards on the very 1st day of PCP.

- 2. Since the PCP's are conducted for the benefit of the CDOE students and as mentioned in the Prospectus 50% attendance in the PCP is COMPULSORY to become eligible to appear in the University examination, they are advised to attend the PCP classes regularly. No exemption from attending the PCP will be allowed in any case. No change of PCP center/batch will be entertained in any case.
- 3. The candidates are also advised to pay the balance  $_{\text{fee}}/2^{\text{nd}}$  Installment fee and submit the deficient documents, if any, immediately to confirm the eligibility for appearing in the University examination failing which they will not be allowed to appear in the University examinations.
- 4. A written test on account of **Internal Assessment** as per scheme of examination during two days of PCP as guidelines issued by Centre for Distance and Online Education.

NOTE: In Case any candidate does not complete the eligibility condition of the course even after attend the PCP his/her candidature will be stand Cancelled/Not eligible. He/She will be allowed to attend the PCP Provisionally
