

Note: In case any candidate does not complete the eligibility conditions of the course even after attending the PCP, his/her candidature will be standing cancelled / not eligible. He / she will be allowed to attend the PCP provisionally.

Since the PCP's are conducted for the benefit of the CDOE students and as mentioned in the Prospectus 50% attendance in the PCP is **COMPULSORY** to become eligible to appear in the University examinations. They are required to attend the PCP classes regularly. No exemption from attending the PCP will be allowed in any case. No change of PCP Centre/batch will be entertained in any case.
2. The candidates are also advised to pay the balance fee/2<sup>nd</sup> Instalment fee and submit the deficient documents, if any, immediately to confirm the eligibility for appearing in the University examinations failing which they will not be allowed to appear in the University examinations.
