Since the PCP's are conducted for the benefit of the CDOE students and as mentioned in the Prospectus 50% attendance in the PCP is COMPULSORY to become eligible to appear in the University examination, they are advised to attend the PCP classes regularly. No exemption from attending the PCP will be allowed in any case. No change of PCP center/batch will be entertained in any case.

3. The candidates are also advised to pay the balance fee/2nd Installment fee and submit the deficient documents, if any, immediately to confirm the eligibility for appearing in the University examination failing which they will not be allowed to appear in the University examinations.

4. A written test on account of 20% and 30% Internal Assessment in each theory paper of PG Dip. In Env. Edu.(Jan.,2023)/AG Dip in Env. End.(July, 2023) and MA (P & F) Env. Edu. during last two days of PCP for the Session January and July, 2023 respectively as per guidelines issued from Centre for Distance and Online Education.

In view of this, the candidates are advised to attend the PCP, though submission of written assignment is not compulsory, the students in their own interest are also advised to submit written assignments on topics concerning their courses for evaluation by the teacher.
